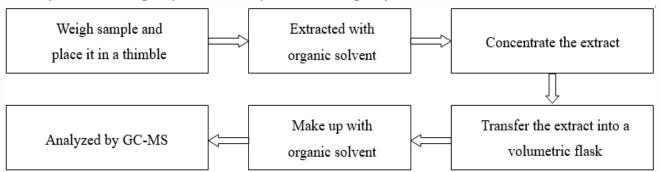




3. Hexavalent Chromium (Cr(VI))



4. Polybrominated Biphenyls (PBBs), Polybrominated Diphenyl Ethers (PBDEs)


